And then on Thursday sharply dropped.

Sri Lankan authorities revised the number of people killed in the near simultaneous blasts at church and luxury hotels in and Colombo and in the disside town of Batticaloa 359 on Wednesday.

A top health minister, Dr. Anil Jasinghe, said bodies had been torn and others had been de-making identification.

But the discrepant death toll was just one of the latest in a pattern of and counterclaims that muddled the investigation of the Islamic State claimed attacks and questioned the government's ability to handle it, as with possible access to explosives reportedly remain at large.
